Adoptions provide a gift to all involved

Almost fifteen years ago, Jenn and Keith Brennan of Millstadt reached out to what was then Catholic Social Services to learn about adoption in order to grow their family. "We didn't even consider another agency. As Catholics, it was the place to go," said Jenn, with a smile. Because the agency promotes open adoptions where there is communication between the birthparents and adoptive parents, they were able to be present at the birth of their daughter, Keri, on Christmas Eve.

Even with the open adoption, Keri and her birthmother had never met but communicated through pictures, emails and letters over the years. When Keri was 12, she expressed a desire to meet her birthmother who now lives in another city. After everyone prepared for the reconciliation through counseling, they arranged to meet Keri's birth mom as well as a brother who is 16 months older. Keri is now building a relationship with her birthmother and her biological brother. Jenn was nervous about them reconnecting, but her friends were protective. Still she says, "she has given us so much, that's the least we could do." Jenn stressed the importance of being open to learning and communicating with the birthmother.

Karcie Wyatt-Clark, Adoption Specialist at Caritas Family Solutions, explained that birthmothers can choose a family to adopt their child, but they don't have to. In these cases, the child is placed with a family who has been waiting the longest. Jenn mused, "What do you say to a child who asks 'why did my mom not want me?' "



Jenn started explaining adoption to Keri when she was about 2-3 years old, primarily through books suitable to her age. When Keri was 8, Jenn explained that "sometimes parents love their children so much, they want a better life for them. They may not be ready for parenting. They choose to give the gift of their child to someone who can't have one."

About this time, the Brennans returned to the agency now known as Caritas Family Solutions to once again begin the adoption process. Now they have a three-year-old son, John, and Keri has a little brother. Keith and Jenn were also present at John's birth and see his birthmother semi-annually.

Like in all families, parenting has been different with each child. Jenn puts it all into perspective, advising others to reach out for support through human contact rather than books or the internet. "It is important to connect with real people not just other's stories that you read." The Brennans are friends with other adoptive parents, even those who've adopted internationally. They strongly believe that as in the rest of life, there are joys and challenges with adoption but with a support system you can work through them.

They offered this additional piece of wisdom: "When waiting for a placement, remember that things go a certain way for a reason. It is part of the journey." Three times, Jenn and Kevin were preparing for a placement that didn't work out. Eventually, their journey led to two children meant just for them.

Jenn said she is tied to the agency for life. "I have a vested interest in promoting adoption and am willing to share our stories.

"Adoption has brought us so much joy. We feel that God gave us a special blessing and journey to find our forever family. It is not unimaginable to think of our lives without children, but it is if we think of our

lives without Keri and John. Caritas opened the door to meeting and matching us with the right birth parents," Jenn concluded.

STAFF SPOTLIGHT: Ramona McNamee

Ramona McNamee has worked as a Residential Treatment Specialist at St. John Bosco Children's Center in Belleville (SJBCC) for more than 23 years. When she was diagnosed with breast cancer in 2013, the staff at the children's center supported her journey to survival. As a result, every October there is an annual Breast Cancer Awareness Pink Staff Appreciation celebration to honor Ramona. The staff found this as a way to rally behind Ramona as well as all breast cancer victims and survivors.

Ramona's first years at SJBCC were at the former location on Church Street in downtown Belleville. Back then, the center provided emergency, short-term care for children, even infants. Since Ramona worked the overnight shift, she was often in the nursery. "I spoiled them," she said. "They'd tell me to put the babies down but I didn't." Although SJBCC has experienced several changes over the years—a move into a now renovated building on Royal Heights Road, different management and approaches, even new children— Ramona admitted it's the children that have kept her here all these years. "They need a lot of love and they look to me for that, like a mother or now a grandmother," she chuckled. "I get the most respect in the building. The kids need love and nurturing and that is what I give."

Having endured surgery, radiation and chemo for her stage three cancer, she was declared cancer free in January 2017. "I feel great," says Ramona. "The sweetest thing is being around the kids. They make me feel good. Even the boys wear pink and tell me 'I'm so glad you survived. We love you, Mona!"

Birth Mother Education Fund

With the philosophy that birth mothers deserve the opportunity for a successful future after adoption, the Bright Futures scholarship fund will support the educational goals of birth mothers in order to help them reach their career and life ambitions. The birth mother must be a current client of Caritas Family Solutions (or up to one-year post-placement) and shall have placed her child for adoption in or after the year 2016. If eligible, the scholarship provides \$500 for up to two semesters of classes, with payment made directly to the college or trade school.

NOTE: Choosing adoption does not guarantee a scholarship will be available to the birth mother. The number of scholarships and the amount of each award might vary depending on the number of applicants applying.
