# Core Practice Model brings changes to foster care

Child welfare in Illinois is changing...for good. According to the current strategic plan for the Department of Children and Family Services (DCFS), the department is going to "immerse" itself in lessons learned and enlist entire communities and their resources to better protect children and youth from abuse and/or neglect.

In the spring of 2018, Caritas Family Solutions was chosen by DCFS as an "immersion" agency to help lead a coordinated, collaborative approach to protecting and helping young people in cases of abuse or neglect. This will occur through implementation of a Core Practice Model.

"We were pleased to learn that DCFS chose Caritas to be a partner in implementing the Core Practice Model," said Caritas CEO Gary Huelsmann. "It is because of our size and excellent performance in foster care that we were asked to be the first, and currently the only, immersion agency in Illinois."

There are approximately 15,050 children and youth in foster care in Illinois at this time; more than 1,300 are managed by Caritas, now the third largest foster care service provider in the state.

Implementation involves training staff in the Core Practice Model which includes trauma-informed care; developing enhanced services, such as intensive placement services; and process changes to include utilizing Child and Family Team Meetings (CFTM) to engage and empower families to drive their own change process. The team meetings encourage full disclosure, open participation, collaboration and planning for permanency.

All foster care staff at Caritas Family Solutions are being trained in the Core Practice Model. The staff in Belleville and Mount Vernon were trained last year; this year Carterville, East Alton and Effingham staffs are receiving the training. Training is provided by the Child Welfare Group through local universities who in turn send the trainers onsite.

"There is a lot of work up front, learning new approaches. But all who go through the training say it seems to be beneficial to do child welfare this way versus how we have been doing it," said Mark Becker, Director of Foster Care at Caritas Family Solutions.

"As a private agency we are very excited about how much DCFS is valuing our input with this immersion

> partnership," added Becker. "We feel we are an equal player at the table and that's refreshing."

> The goal is to eventually implement the Core Practice Model statewide with an overall goal to reduce the length of time a family needs to be involved in the child welfare process. It's a win-win situation for all

Kickoff events are planned for October 18 and 19 to introduce the Core Practice Model to those most involved in foster care throughout Southern Illinois: caseworkers, attorneys, judges and other professional support personnel such as counselors, teachers and foster parents.

### It's Permanent!

The new tax reform law brings the ability of donors age 70.5 and older to donate the distribution from an Individual Retirement Account (IRA) to a charity. Now that the law is permanent, the donor's "required minimum distribution" each year can be distributed in part or in whole to a qualified charitable organization in order to avoid paying tax on the distribution. ### Permanent employment is music to the ears for SCSEP

Brenda Lancaster, recent participant in our Senior Community Service Employment Program (SCSEP) and an alumna from Lewis and Clark Community College (LCCC), has been hired to instruct the school's first Gospel Choir, a new addition to the Music Department's curriculum for the Fall 2018 semester.

Lancaster joined SCSEP in 2017, and was assigned to the LCCC Music Department, where she served as music assistant and vocal coach for the LCCC Rock Ensemble, under the direction of Music Coordinator Louis Michael. Caritas' SCSEP has been working with government and non-profit organizations (including educational institutions such as LCCC) since 1974 to help provide training and additional work experience for those 55 and older.

SCSEP gave Brenda a foot in the door to her new position, for which she is grateful. "I was looking to supplement my retirement income when I learned about SCSEP. It has opened so many opportunities, so many doors, that otherwise would not have been there for me without first participating in SCSEP," she said.

Her first placement was at Caritas, where she was responsible for recruiting more host agencies in Madison County for the program. She was successful at getting LCCC on board.

Prior to SCSEP, Lancaster's experience included helping to organize the Riverbend Community Gospel Choir, where she serves as the director and vocal coach, and serving as a planning committee member for the Pie Town Music Festival. She served as the Minister of Music at the Greater St. James Baptist Church in Alton for 14 years and as a booking agent for the Music

Association of St. Louis (MASL) for three years.

Lancaster graduated from LCCC with an Associate in Arts degree and went on to pursue a Bachelor of Arts in Music Business at SIUE.

Students can join her Gospel Choir just for fun or for credit, the latter fulfilling one requirement for an A.A. in Music Production. "SCSEP was very important in helping me acquire employment on campus and is really the main reason I am able to have this position," said Lancaster. "I know this is by design; I've been doing this all my life. But SCSEP had a way of jumpstarting a whole new chapter in my life."

The Department of Labor provides funding for SCSEP because helping older adults remain in the workforce provides a boost to our national economy: These workers pay taxes and cover more of their own expenses during their later years. Contrary to ageist stereotypes, older workers are a good investment, rating high on characteristics such as judgment, commitment to quality, attendance, and punctuality.
