From the Manager

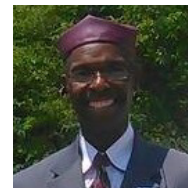
As the COVID-19 pandemic restrictions loosen a little; with summer on the horizon, now's the time to consider a few tips for seniors applying for summer jobs.

Contrary to popular opinion, employers really do like to hire older workers for seasonal jobs. Mature workers' flexible schedules often accommodate the summer season.

The majority of employment opportunities are for three months. However, many of these positions can also be offered as year-round jobs. And, don't forget the best part. If a

participant takes on one of these positions, and exits the program; if the position ends, the participant is eligible to rejoin the program.

SCSEP 48 Month Lifetime Participation Duration Limit is Extended!

The Older Americans Act, the authorizing legislation for SCSEP, requires that Participants may remain in SCSEP for a maximum period of 48 months or 4 years. In most cases participants do not participate for the entire 48 months as they leave for unsubsidized placements or other personal reasons. Caritas Family Solutions tracks enrollment time by the entering of Participant data into SPARQ, the Department of Labor database. Each participant must be exited when participant must be exited when he/she reaches their individual four year durational limit date.

Last month, DOL provided official guidance on new provisions for SCSEP stemming from the recently passed COVID-19 stimulus bill, the CARES Act. The CARES Act allows the Secretary of Labor to extend participation on SCSEP for a period beyond

the 48-month Individual Durational Limit (IDL) if an extension is warranted due to the effects of COVID-19.

The good news is that the Secretary of Labor does feel that an extension of the 4 year IDL is warranted due to the widespread and ongoing impact of the COVID-19 emergency on SCSEP grantees and participants.

Therefore, all participants who were enrolled as of March 1, 2020 are receiving an automatic 12 months extension. This extension also applies to any new enrollments from March 1 – August 31, 2020, and any IDL exits on or after March 1, 2020.
