SCSEP is funded by a \$45.2 million grant from the U.S. Department of Labor. This funding provides 90% of the support for SCSEP with The Center providing 10% match or \$5 million. The SCSEP Program is an equal opportunity program. Auxiliary aids and services are available upon request to individuals with disabilities.

Caritas SCSEP Host Agency: The Urban League of Metropolitan St. Louis

A key purpose of SCSEP is to enable older workers to achieve gainful employment and personal development through community service and training; which is provided by a partnership with Host Agencies; defined as community-based non-profit organizations with a 501(c)(3) designation or a government entity that provides part-time training and supervision.



One such agency is the National URBAN LEAGUE Urban League of Metropolitan St. Louis which exists to empower

African-Americans and others throughout the region through community programs in three counties across the bi-state region; and helps its clients to climb out of poverty by helping them in securing economic self-reliance, social equality, and civil rights. Although headquartered on the Missouri side of the river; two (2) locations have been provided to serve the Illinois market in Fairview Heights and East St. Louis.

The NUL St. Clair County Operations office is spearheaded by DOO, Kesha Chapman, who has had a relationship with SCSEP for many years; and because of this, recently provided an opportunity to a SCSEP participant who has been with the program for five (5) years, Tannie Morris.

Many of our other SCSEP host agency supervisors have also found that as permanent jobs become available at their agencies, they are able to fill the positions with trained SCSEP participants, already well versed in the mission of the agency, rather than starting over with untrained or unfamiliar job applicants.
