This Waiver shall be governed by the internal laws of the State of Illinois and that the Circuit Court of St. Clair County shall have jurisdiction over this Waiver and Release of Liability. If any portion of this Waiver shall be deemed to be invalid, then the remainder of this Waiver shall remain in full force and effect. This Waiver constitutes the entire agreement and understanding of the Parties and supersedes all prior communications between them and/or their representatives, oral or written, relating to the Event.
